## STUDENT HOSTING CONDITIONS

I.- A Host Family who accommodates one of our students must agree to the following basic terms and conditions:

- To provide single room accommodation unless specifically requested otherwise.
- Never to accommodate more than one Spanish speaking student in their home at any time unless specifically arranged with us otherwise.
- To provide breakfast, a packed lunch and a cooked evening meal Monday to Friday and to provide full board on Saturdays and Sundays. The student will expect to sit at the meal table with the family.
- To meet the student at the pick-up point on the arrival day and to deliver the student to the departure point in good time to catch the coach on the departure day.
- To take the student to, and collect him/her from the school or the meeting point on the first day.
- To take and collect the student before and after the CIB Party.
- To include the student in family weekend activities.
- To take the appropriate action if a student is taken ill or needs to visit the doctor/dentist, informing the Student Hosting co-ordinator and Group Leader accordingly.
- To follow all the directives regarding the time the student should be at home in the evenings and at weekends.
- To accept that we cannot be held responsible for damage or breakages caused to host family property by the student or for any debt incurred by the student.
- Not to allow the return of the student through alternative channels without our logistical backing.

II.- The information given in this application form may be held on a database and used by us solely for the purposes set out in this clause: We will use your information to maintain and develop our relationship with you. We do not disclose your information outside our company beyond the purposes set out in this agreement.

III.- CIB (trading as SHHE) acts as an introductory agent. For commercial reasons the £500 introductory fee is waived. However, CIB reserves the right to claim the introductory fee from student hosting families who privately accommodate the students initially placed with them through SHHE within the 24 months following the students' departure date.
